Sub: Non-Applicability of Regulation 27(2) of SEBI (Listing Obligations and Disclosure Requirements), 2015.

This is with reference to Regulation 15 (2) of the SEBI (LODR) Regulation 2015, which states that with regards to compliance with the corporate governance provisions as specified in Regulation 27 shall not apply in respect of:

1. The listed entity having paid up equity share capital not exceeding rupees ten crores and
2. The listed entity having net worth not exceeding rupees twenty five crores, as on the last day of the previous financial year.

Please take note that as on 31<sup>st</sup> March 2020 the paid up equity share capital of our Company is Rs. 40,00,000/- (Rupees Forty Lakhs only) and our net worth is Rs. 1,96,13,260 (Rupees One Crore Ninety Six Lakhs Thirteen Thousand Two Hundred and Sixty only).
