### SCRUTINIZER'S REPORT

[pursuant to the provision of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as Amended]

Dear sir,

I, CS Shilpa K Dhulapkar, Company Secretary in Practice (FCS No. 7235, CP No. 7615), was duly appointed as a Scrutinizer by the Board of Directors of Govind Poy Oxygen Limited (the Company) for the purpose of scrutinizing the remote e-voting process and voting by poll in a fair and transparent manner and ascertaining the requisite majority on poll and remote e-voting (referred as "E-voting" in respect of the below mentioned resolutions proposed at the 50<sup>th</sup> Annual General Meeting ("AGM") of Govind Poy Oxygen Limited held on Monday, **September 26<sup>th</sup>, 2022** under the provisions of Section 108 of the Companies Act ,2013 (the "Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended

I was also appointed as Scrutinizer to scrutinize the e-voting process during the said AGM.

The notice dated 12<sup>th</sup> August, 2022, convening the AGM, as confirmed by the Company, was sent to the shareholders in respect of the below mentioned resolutions proposed to be passed at the AGM of the Company through electronic mode to those Members whose email addresses are registered with the Company/ Depositories, in compliance with the Ministry of Corporate Affairs circulars dated May 5, 2020 and Januar13, 2021 read with circulars dated April 8, 2020 and April 13, 2020 (collectively referred to as "MCA Circulars") and SEBI Circulars dated May 12, 2020 and January 15, 2021.



The Company had availed the e-voting facility offered by Central Depository Service Limited ("CDSL") for conducting remote e-voting by the Members of the Company.

The voting period for remote e-voting commenced on Friday 23<sup>rd</sup> September 2022 at 9 a.m. (IST) and ended Sunday 25<sup>th</sup> September 2022 at 5 p.m. (IST) and the CDSL e-voting platform was disabled thereafter.

The Company had also provided e-voting facility to the Members present at the AGM who has not cast their vote earlier.

The Members of the Company holding shares as on the "cut-off" date i.e. September 19, 2022 were entitled to vote on the resolutions as contained in the Notice of the AGM.

After the closure of e-voting at the AGM, the report on e-voting done during the AGM and the votes cast under remote e-voting facility prior to the AGM were unblocked and counted.

I have scrutinized and reviewed the remote e-voting prior to and e-voting during the AGM and votes cast therein based on the data downloaded from the CDSL e-voting system.

At the said AGM the Chairman of the Company had suo motto called for a Poll to facilitate the members present in the meeting who could not participate in the e-voting to record their votes through the poll process. The Chairman of the AGM had appointed me as the Scrutinizer for the same.

I had appointed Mr. Prashant Patil, who is not in employment of this Company as an Associate to supervise and validate the poll process.

After the time fixed for closing of the poll by the Chairman, one ballot box kept for polling was locked in presence of members, with due identification mark placed by my associate.

The locked ballot boxes were subsequently opened in my presence and poll papers were diligently scrutinized. The poll papers were reconciled with the records maintained by the Company and the authorizations / proxies lodged with the company.

I did not find any poll papers invalid.

The Management of the Company is responsible to ensure compliance with the requirements of the Act and Rules relating to voting by polls and remote e-voting prior to and e-voting during the AGM on the resolutions contained in the notice of the AGM.



My responsibility as Scrutinizer for the remote e-voting, e-voting and voting by poll is restricted to making a Scrutinizer's Report of the votes cast in favour or against the resolutions.

I now submit my consolidated report as under on the result of the remote e-voting prior to and e-voting during the AGM and voting by poll in respect of the said resolutions.


